



## Notification of Dilution of Voting Rights

**Hong Kong, Shanghai, & Florham Park, NJ: Wednesday, April 14, 2021:** Hutchison China MediTech Limited (“HUTCHMED”) (Nasdaq/AIM: HCM) was notified that CK Hutchison Holdings Limited (“[CK Hutchison](#)”) shareholding<sup>[1]</sup> in HUTCHMED remains unchanged, at 332,478,770 ordinary shares of par value US\$0.10 each in the capital of HUTCHMED (“Shares”).

Each American Depositary Share (“ADS”) represents five Shares. As announced on April 8, 2021, HUTCHMED issued a total of 16,393,445 Shares (equivalent to 3,278,689 ADSs) to funds affiliated with Baring Private Equity Asia. HUTCHMED was notified on April 14, 2021 that this issuance diluted CK Hutchison’s holding<sup>[1]</sup> to 44.66 per cent of the total number of voting rights of HUTCHMED. The date on which the notification threshold was crossed was April 14, 2021.
