

HUTCHMED (China) Limited (the "Company") Online User Guide for Annual General Meeting on May 13, 2025 (the "AGM")

The AGM will be an electronic/hybrid meeting. In addition to physical attendance, shareholders of the Company (the "**Shareholders**") can attend, participate and vote at the AGM electronically through online access at https://meetings.computershare.com/Hutchmed2025AGM (the "**Online Platform**").

The Online Platform will be open for registered Shareholders, non-registered Shareholders, as well as their proxies and corporate representatives to log in approximately 30 minutes prior to the commencement of the AGM (i.e. from 3:30 pm Hong Kong time (8:30 am London time) on May 13, 2025) and can be accessed from any location with Internet connection by a smart phone, tablet device or computer. Please refer to the Company's circular to Shareholders and notification letter to Shareholders both dated April 8, 2025 (the "Notification Letter") for login details and arrangements. 和黃醫藥(中國)有限公司(「本公司」) 於2025年5月13日舉行的股東週年大會(「大會」) 網上用戶指南

大會將以電子/混合會議形式舉行。本公司股東(「**股東**」)除親臨出席大會外,亦可以電子方式透過網站(https://meetings.computershare.com/Hutchmed2025AGM)(「**網上平台**」) 於線上出席、參與大會並於會上投票。

網上平台將於大會開始前約30分鐘(即由2025年5月13日香港時間下午3時30分(倫敦時間上午8時30分)起)開放予登記股東、非登記股東,以及其受委代表及公司代表,透過智能電話、平板裝置或電腦於任何有互聯網連線的地點登入。登入詳情及安排請參閱本公司日期於2025年4月8日致股東的通函及通知信函(「**通知信函**」)。股東如對登入詳情及大會整體安排有任何疑問,請聯絡(a)本公司的香港股份過戶登記分處香港中央證券登記有限公司,地址為香港灣仔皇后大道東183號合和中心17M樓,或致電其電話熱線 +852 2862 8558;或(b) 本公司股份過戶登記總處Computershare Investor Services (Jersey) Limited,地址為c/o Computershare Investor Services PLC, The Pavilions, Bridgwater Road, Bristol, BS99 6ZY, United Kingdom,或致電其電話熱線+44 (0)370 707 4040(統稱「**中央證券**」)。

以下為有關使用網上平台的若干指引。如股東於使用網上平台時遇到任何技術問題或需要協助,請於大會舉行當日香港時間下午3時至下午5時30分(倫敦時間上午8時到上午10時30分)致電中央證券,電話號碼為+852 2862 8558或+44 (0)370 707 4040。請注意,該電話熱線無法在通話過程中記錄 閣下的投票。

Some pointers:

- 1. You will need a reliable Internet connection that is fast and stable enough to support video streaming (for example, as if you are watching a YouTube video).
- 2. However, unlike YouTube, if your Internet connection is not fast or stable enough to support video streaming or keep pace with the AGM proceedings, part or parts of the AGM online broadcast may be lost or skipped. You will not receive the broadcast on a delayed basis and may miss part or parts of the AGM proceedings.
- 3. If your Internet connection is unstable or inadequate, resulting in the video streaming of the AGM being interrupted, you may be unable to vote or submit questions. This will not affect the AGM itself which will continue and will remain valid and effective
- 4. When your Internet connection is restored, you might be able to rejoin the AGM online but you may have missed part or parts of the AGM proceedings (including the voting session) which will not be repeated. You may also need to login again using the login details sent to you.
- 5. Each set of Shareholder login details can only be used on one device (for example, smart phone, tablet device or computer) at a time, and cannot be shared with others.
- 6. You are recommended to participate the AGM via tablet device or computer for the best experience, and to test the compatibility of your device/web browser by logging in earlier prior to the commencement of the AGM.

The online AGM is technology-dependent and the above are some of the possible risks with respect to an online meeting. To ensure your right to vote is exercised, you might want to appoint the Chairman of the AGM as your proxy by returning a completed and signed form of proxy no later than 48 hours before the time for holding the AGM. Alternatively, you can choose to appoint another person as your proxy in accordance with the arrangements for proxy appointment in advance of the AGM as set out in the Company's circular dated April 8, 2025.

用戶指引:

- 1. 閣下將需要可靠的互聯網連線,其速度及穩定性須可支援視頻串流(如同觀看YouTube影片一樣)。
- 2. 但與YouTube不同,如 閣下的互聯網連線速度或穩定性不足以支援視頻串流或未 能與大會過程保持同步, 閣下將可能接收不到或跳過網上大會部分直播內容,而 直播內容將不會延遲播放, 閣下可能因而錯過部分大會過程。
- 3. 如 閣下的互聯網接收不穩定或不足或受到干擾而令大會之互聯網直播可能會被中 斷, 閣下會因此無法投票或提交問題。這情況將不會影響大會本身的運作,大會 將繼續進行並維持有效。
- 4. 當 閣下的互聯網連線回復正常, 閣下可重新參與網上大會,惟可能已錯過部分大會過程(包括投票環節),而這些過程將不會重覆。 閣下亦可能需要重新輸入發送予 閣下的大會登入資料以便再次登入網上平台。
- 5. 每組股東登入資料僅能在同一時間於一個裝置(如智能電話、平板裝置或電腦)上 使用,並且不能與他人共用。
- 6. 本公司建議 閣下使用平板裝置或電腦參與大會以獲得最佳體驗,並應在大會開始 前提前登入,以測試 閣下的裝置/網絡瀏覽器與網上平台的兼容性。

網上大會需要科技配合,上述情況僅為部分有關網上會議的潛在風險。為確保 閣下的投票權利得以行使, 閣下或擬於大會指定舉行時間前不少於48小時內交回已填妥及簽署的代表委任表格,以便委任大會主席為 閣下的受委代表。 閣下亦可選擇按照本公司於2025年4月8日發出的通函所載,有關大會舉行前委任代表之安排委任他人為 閣下的受委代表。



- **股東編號**:請使用列印於通知信函(英文版)右上角條碼下,以字母「C」開始之股東參考編號。
- 密碼:請輸入列印於股東參考編號下的 五位數字個人識別號碼 (PIN)。



For non-registered Shareholders, proxies or corporate representatives of Shareholders:

You will receive an invitation email with a meeting web link if you have provided your email address. Upon clicking the web link, you will be directed to the meeting page. Click "Join Meeting Now" and click "Sign In".

Alternatively, you can select "Invitation" and enter your invitation code. The invitation code can be found in the invitation email.



Once logged in, you will see the AGM Online Platform homepage which displays the webcast screen.

Click on "Broadcast" at the upper left corner of the screen to watch the broadcast.

The broadcast will start automatically when the AGM commences.

You can enter your vote(s) as soon as the resolution(s) are displayed on the screen. To vote on a resolution, click on one of the voting options ("For" or "Against" or "Withheld"). Your vote will be highlighted and confirmed.

To change your vote, simply click "Click here to change your vote" to override. The final option you click before the voting closes shall be your final yote for the resolutions concerned

If you would like to pose a question during the AGM, click on the "Q&A" tab on the top of the screen. You can type your question in the text box in English or Chinese (maximum 1,000 characters) and then submit by clicking the "Send" tab.

Your submitted question will only be seen by the Company's representatives but not other attendees at the AGM.
